

The IOM mission in Mali was established in 1998. Through the implementation of different projects in the country, IOM provides humanitarian assistance to both international migrants and Internally Displaced Persons (IDPs).

Staff and Geographical coverage

The IOM Mali's activities are implemented countrywide through a main office in **Bamako** and three sub-offices in **Mopti**, **Timbuktu** and **Gao**. Currently the mission has some 200 staff members.

IOM in Mali has significantly increased its operations after the crisis in 2012.

Internally Displaced Persons (IDPs)

- **Displacement Tracking Matrix** established to track and monitor population movements
- **128,866 people*** currently Internally displaced
- **353,695 returnees*** currently identified in the northern regions of Gao, Mopti, Timbuktu and Kidal
- **Leadership** of the Commission on Movements Population (CMP)
- **Flow Monitoring Points (FMP)** established in the entry and transit points of the main cities
- **Reports** produced and disseminated weekly (FMP reports), monthly (CMP report) and bimonthly (DTM report) to the Government and humanitarian community

Protection

- **4,642 individuals** provided with protection assistance including counseling, psychosocial and mental support as well as emergency assistance and referral to specialized agencies
- **Protection Referral System** in place for referral of protection cases throughout the country
- **Rapid Response Fund** in place to provide food, temporary shelter, NFIs, medical care and transportation to the most vulnerable population
- **Operational Mapping of Protection Services** in place including over 150 relevant institutions identified as providers of protection's related services
- **Protection evaluations** implemented in areas with high vulnerabilities in the northern regions

The IOM projects in Mali are implemented in coordination with the Malian Government through the financial support from:

- **Leadership** of the Inter- agency Child Protection Information Management System (IACPIMS) in Bamako
- **Identification of Gender Based Violence (GBV) victims** and referral to specialized organizations cases of victims of GVB
- **Capacity building and training on protection** to Government officers, journalists, militaries and civil society

NFI Shelter and Non-Food Items (NFI)

- **947 IDP households** (6,250 individuals) benefitted with cash for rental support in Bamako, Mopti and Timbuktu.
- **1,175 IDP households** (7,755 individuals) provided with NFI kits in Bamako, Mopti and Timbuktu.

Water, Sanitation and Hygiene (WASH)

- **12 water points** rehabilitated in 10 villages in Mopti
- **1,397 households** (9,226 individuals) provided with access to potable water and hygiene promotion activities in Mopti
- **Hygiene promotion activities** in 10 villages in Mop. IOM is currently expanding WASH activities in Gao and Timbuktu

Health

- **48 health community centers** supported through distribution of medicines.
- **15,360 IDPs and other vulnerable population** provided with health care

Early recovery and community stabilization

- **812 income generating activities** for most vulnerable households in the regions affected by the conflict with high number of returnees and IDPs
- **5,358 individuals** benefitted from income generating activities

Emergency evacuations and voluntary return and reintegration

- **1,820 stranded Malian migrants** evacuated in coordination with the Malian Government from the Central African Republic
 - **12,637*** Malian migrants supported to voluntary return from Libya after the crisis in 2011
 - **215**** Malian migrants supported to voluntary return from other countries
 - **498** returnees have received reintegration support

Border Management

- **Capacity building in migration management** of immigration officers
- **Strengthening of institutional capacity** through the rehabilitation and construction of border posts
- **Provision** of border control equipment

Migration and environment

- **Reduce the vulnerability** of populations exposed to environmental risks
- **Strengthening the capacity** of the Malian Government and other stakeholders to face the challenge of environmental migration and climate change adaption.
